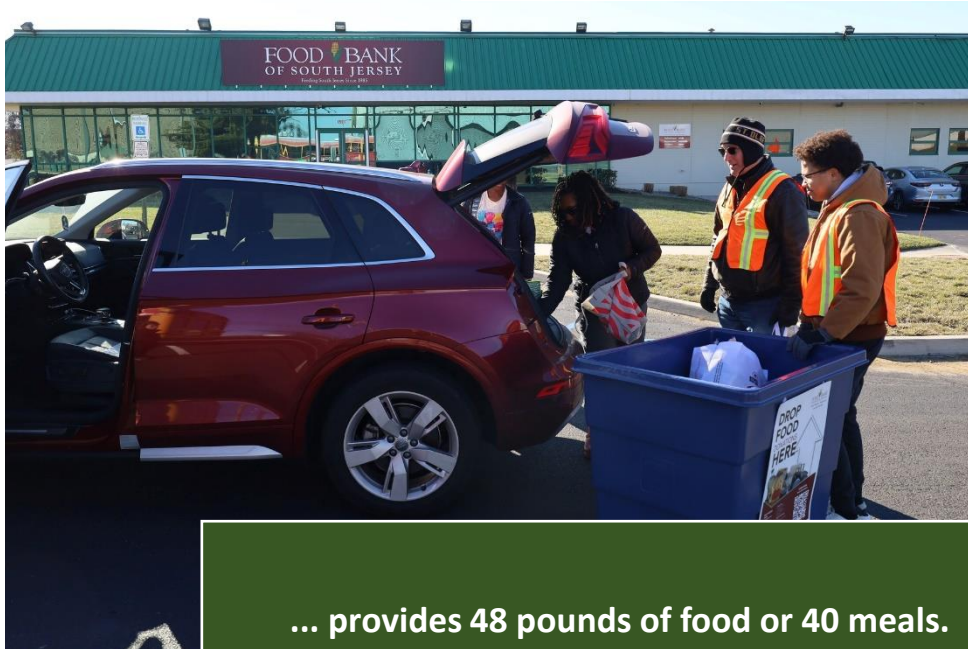

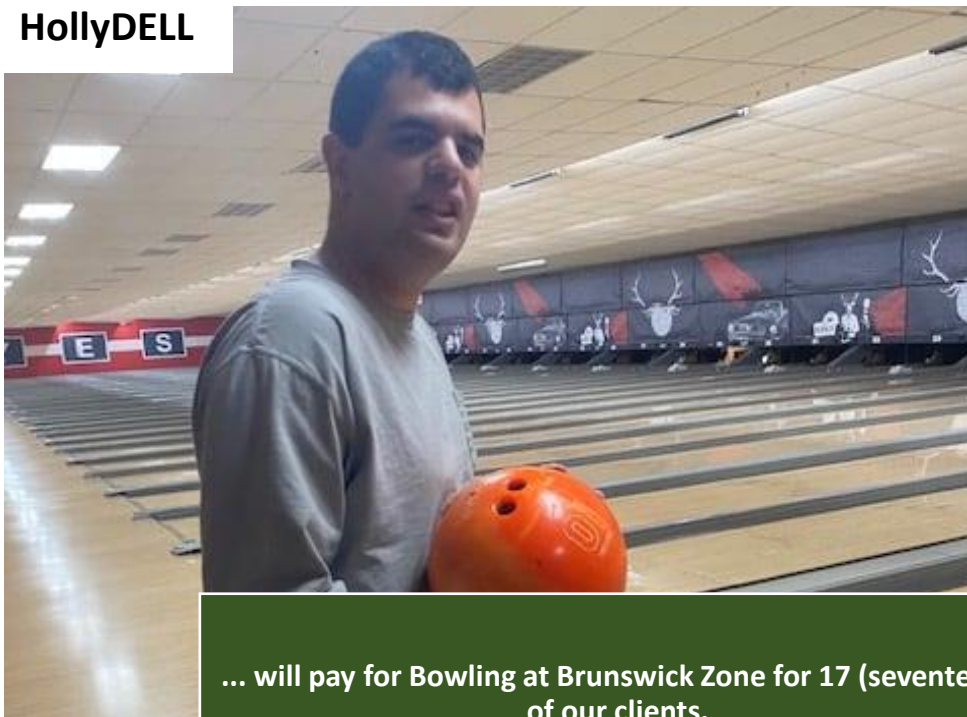


Glassboro Child Development Center
