...will provide 1 year of free tutoring for a student.



MARYVILLE ADDICTION TREATMENT CENTER - Residential Substance Use & Co-occurring Mental Health Services

...will provide 2 days of short-term residential treatment.

REPAUNO PRESCHOOL DAY CARE CENTER - Infant & Preschool Childcare and Early Education

...will provide for one month of full-time infant childcare services for an at-risk child.



SAMARITAN HEALTHCARE & HOSPICE - Center for Grief Support

...will cover the expenses associated with website updates and promotion of grief support services.



VOLUNTEERS OF AMERICA - Eleanor Corbett House

...will fund 10 days of emergency shelter services for one individual, or 2 days of emergency shelter services for 5 individual family members: inclusive of case management, 24/7 on-site supervision and support, transportation, meal service, and workshop programming (i.e., Life Skills, RentSmart Tenant Curriculum, Strengthening Families).
