# What can a payroll deduction of \$10 per week (\$520 per year) provide?



**Maryville** - this could provide close to one month of sober living rent.



**HollyDELL** - will pay for 1 month of auto insurance for 3 of our vehicles.



**Literacy NJ** - can provide 1 year of free tutoring for a student.

# What can a payroll deduction of \$10 per week (\$520 per year) provide?



**Volunteers of America, Delaware Valley** - will fund 10 days of emergency shelter for 1 person, or 2 days of emergency shelter for 5 family members, including case management, 24/7 on-site support, transportation, meal services, and workshop programming.



**Volunteer Center of South Jersey** - will cover a stipend paid to Youth Workforce Development Fellows at the completion of their internship.



**Center for People in Transition** - will provide half the funding needed to sponsor an 8-week Bereavement Support Group by a licensed professional counselor for up to 25 people in the County.



# What can a payroll deduction of \$10 per week (\$520 per year) provide?



**Center for Family Services** - will provide kitchen & bathroom packets for women leaving the program, including dishes, flatware, measuring spoons, kitchen towels, can opener, shower curtain, bath set, and a vacuum cleaner.



**Food Bank of South Jersey** - provides 3,133 pounds of food (the equivalent of 2,610 meals) or 348 Kids Packs.



**Big Brothers Big Sisters Independence** - will pay for group activities for matches, such as visits to museums, sporting events, arts and crafts workshops, and community events.

# What can a payroll deduction of \$10 per week (\$520 per year) provide?



**Boy Scouts of America Garden State Council** - will cover one week of Resident Camp for a Boy Scout, a Scout Uniform shirt, pants, and sleeping bag.



**Girl Scouts of Central & Southern NJ** - would provide the resources needed for an entire troop to take a field trip where they discover new things, connect with other people, and explore the world around them.



**Repauno Preschool Day Care Center** - would feed 42 food-insecure preschoolers hot, nutritious meals every day for a month.

# What can a payroll deduction of \$10 per week (\$520 per year) provide?



**Glassboro Child Development Center**  
- provides ten staffmembers a two-year First Aid and CPR certification.



**YMCA Gloucester County** - would provide healthy snacks for all of our after-school kids for one week.
