

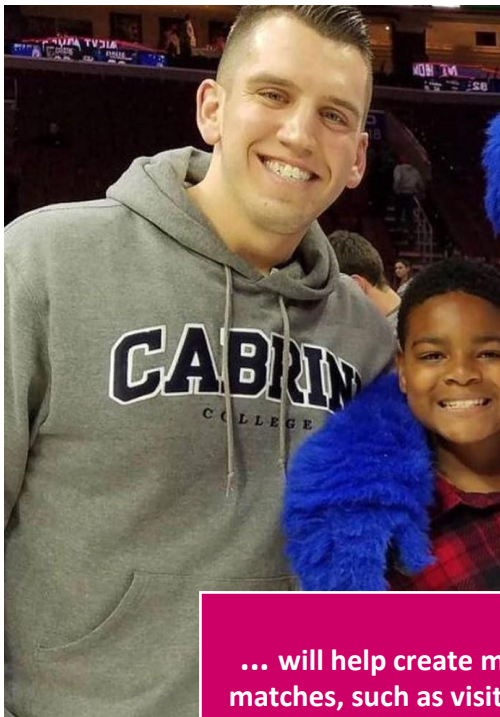

... will help create memories by funding group activities for matches, such as visits to museums, sporting events, arts and crafts workshops, and community events.

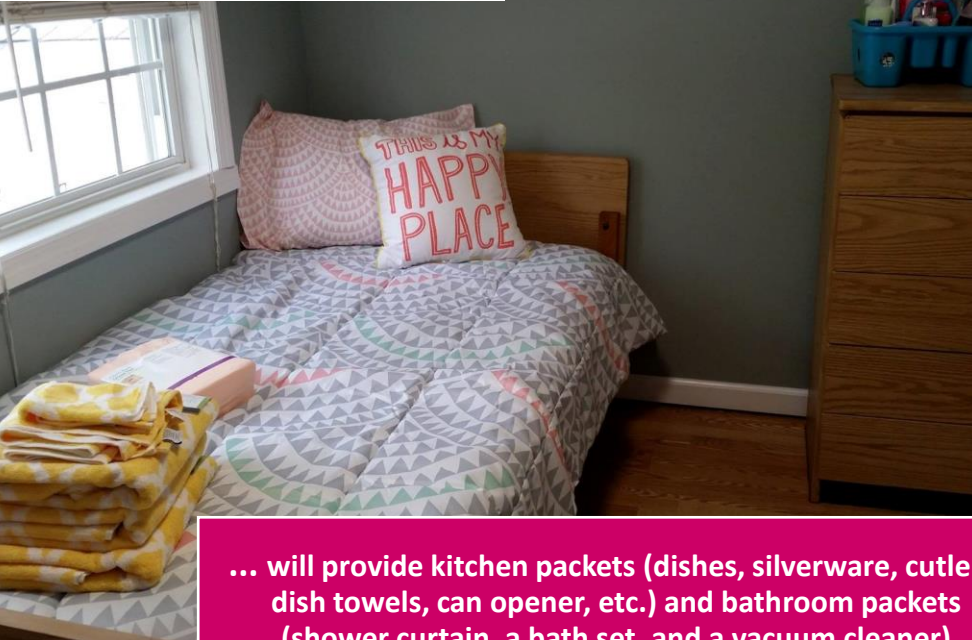

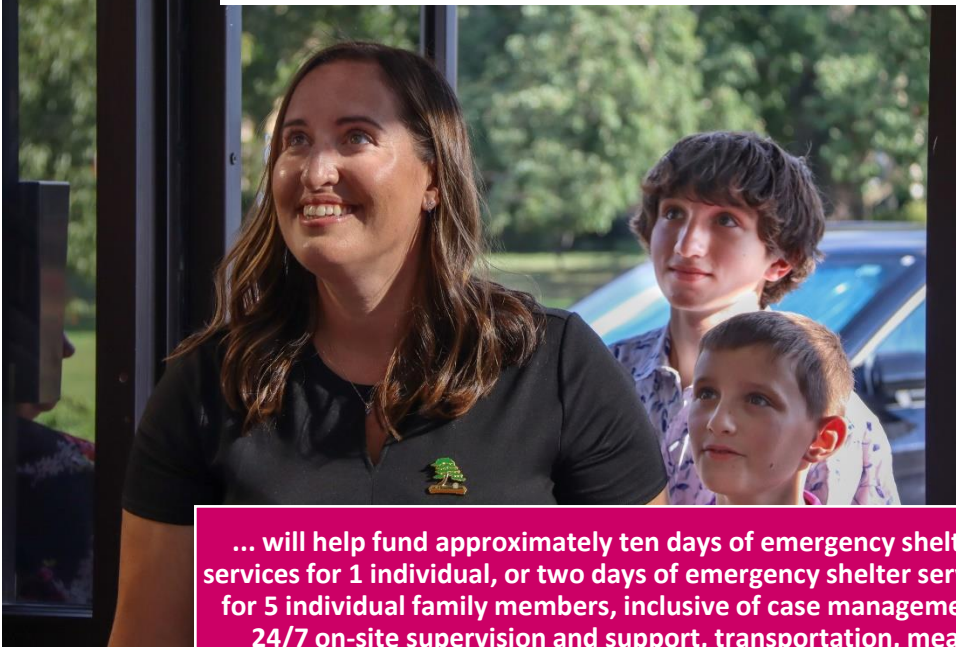


## Samaritan Healthcare & Hospice
