

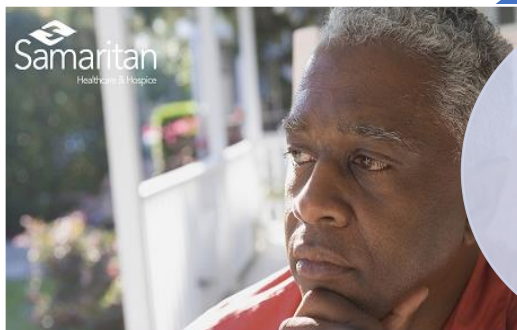
What can a payroll deduction of \$2 per week (\$104 per year) provide?



Famcare - will fund testing for Human Papilloma Virus (HPV) using Thin Prep for 3 patients.



Arc Gloucester Camp Sun 'N Fun - will buy food thermometers for the kitchen for 50 days of operation.



Samaritan Healthcare & Hospice - can cover the expenses associated with conducting a monthly group grief support meeting online or in-person.

What can a payroll deduction of \$2 per week (\$104 per year) provide?



Maryville - funds can pay for transportation in order to connect a client with community resources.



HollyDELL - will purchase a tank of gas so that we can transport our clients to a point of interest, such as Adventure Aquarium in Camden.

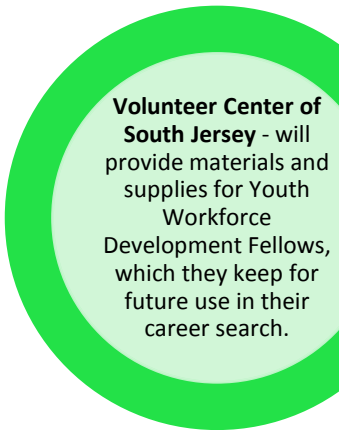


Literacy NJ - can provide 10 hours of free tutoring for a student.

What can a payroll deduction of \$2 per week (\$104 per year) provide?



Volunteers of America, Delaware Valley - will fund 2 days of emergency shelter for 1 person or 1 day of emergency shelter for 2 family members, including case management, 24/7 on-site support, transportation, meal services, and workshop programming.



Volunteer Center of South Jersey - will provide materials and supplies for Youth Workforce Development Fellows, which they keep for future use in their career search.



Center for People in Transition - will allow 4 people to receive one-on-one assistance with resume preparation.

What can a payroll deduction of \$2 per week (\$104 per year) provide?



Center for Family Services - will provide a cleaning supply basket for their new home to include a laundry basket, detergent, mop, bucket, disinfectant, Clorox wipes, toilet cleaner, toilet paper, floor cleaner & glass cleaner.



Food Bank of South Jersey - provides 627 pounds of food (the equivalent of 522 meals) or 70 Kids Packs.



Big Brothers Big Sisters Independence - will pay for resources to conduct in-depth interviews of families enrolling their children.

What can a payroll deduction of \$2 per week (\$104 per year) provide?



Boy Scouts of America Garden State Council - will cover a child's Annual Registration, Program Fee, and a year's subscription to Scout's Life.

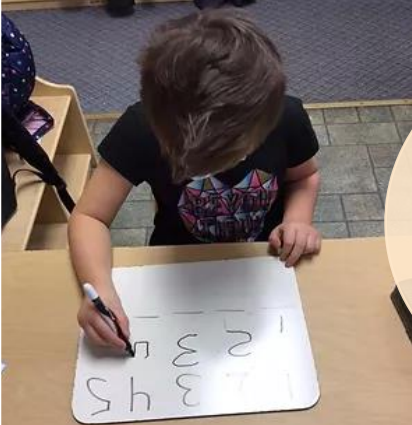


Girl Scouts of Central & Southern NJ - in addition to membership and one badge program, would allow a girl to explore the outdoors: hiking, canoeing, rock climbing, and cooking healthy over an open fire, at Girl Scout Camp for a day.



Repauno Preschool Day Care Center - will supply 30 preschoolers with individual boxes of crayons, markers & Play-Doh, fostering fine motor skills & small muscle development while keeping the spread of germs to a minimum.

Glassboro Child Development Center - will feed a child lunch every day for the entire summer learning program.



YMCA Gloucester County - would purchase an enrichment pack for 1 student at our site to get the homework help they need to close any learning gaps.
