

What can a payroll deduction of \$5 per week (\$260 per year) provide?



The Arc Gloucester - will provide entertainment for one evening from an outside vendor such as a magician. Or, food supplies, ring light, and software to host group camp sessions for one week of camp group.



Big Brothers Big Sisters Independence Region - creates an enriching game, craft, activity and conversation starter idea bin for a school-based program. Matches would use this bin during visits to museums, sporting events, arts and crafts workshops, and community events.



Boy Scouts of America, Garden State Council - will provide for one week at Day Camp for a Cub Scout and Cub Family Adventure Overnighter.

What can a payroll deduction of \$5 per week (\$260 per year) provide?



Center for Family Services - provides emergency food for a family upon entrance into the program; also supplies such as clothing, pampers, and baby wipes for the children, and career clothing for mothers.



The Center for People in Transition - will provide 22 hours of individual career assistance, including job search skills, interviewing skills, applying for jobs online, and providing job leads to clients.



FamCare - provides for breast ultrasounds for two patients, plus two cervical cancer screening tests or STD tests for two male patients

What can a payroll deduction of \$5 per week (\$260 per year) provide?



Food Bank of South Jersey - provides for 1,566 pounds of food (the equivalent of 1,305 meals).

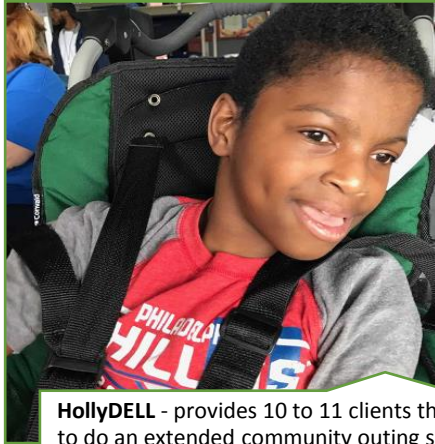


Girl Scouts of Central & Southern NJ - will cover, on average, an entire year of the Girl Scout Leadership Experience, including her membership, uniform, and all the supplies she needs to have many hands-on and girl-led adventures.



Glassboro Child Development Centers - pays for a student to receive one-to-one tutoring at our program during the school day for 2 weeks.

What can a payroll deduction of \$5 per week (\$260 per year) provide?



HollyDELL - provides 10 to 11 clients the ability to do an extended community outing such as a Phillies game and have their medical issues addressed, including the administration of medication and the monitoring of potential life-threatening issues.



Literacy New Jersey, Gloucester County - provides for 6 months of free tutoring for a student.

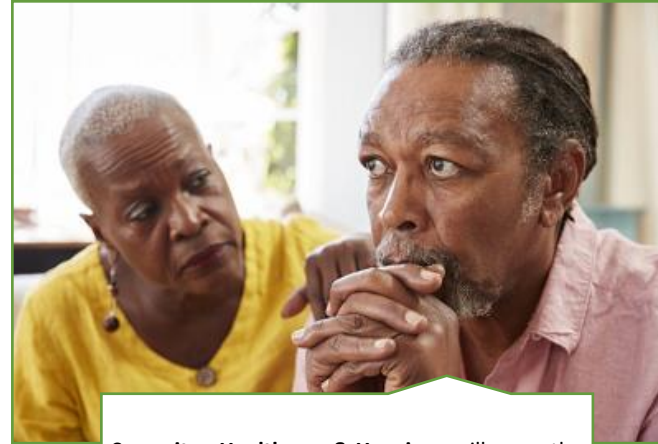


Maryville Addiction Treatment Center - assists in the provision of psychiatric evaluation, individual and group therapy and medications for a Gloucester County resident in treatment at Maryville for addiction and co-occurring disorders.

What can a payroll deduction of \$5 per week (\$260 per year) provide?



Repauno Preschool Day Care Center - will help provide transportation for 30 preschoolers to travel to the Please Touch Museum for a STEAM (Science, Technology, Engineering, Arts & Mathematics) interactive demonstration.



Samaritan Healthcare & Hospice - will cover the expenses associated with off-site group grief support meeting locations.



Volunteers of America - will fund approximately 5 days of emergency shelter services for 1 individual, or 1 day of emergency shelter services for 5 individual family members, including case management, 24/7 on-site supervision and support, transportation, meal service, and workshop programming.
